## PENSION BOARD MINUTES OF JUNE 2, 2015 SPECIAL MEETING

Trustee Michael Obman called the June 2, 2015 meeting of the Board of Trustees of the Plainfield Firefighters' Pension Fund to order at 10:00 a.m. with the Pledge of Allegiance at the District Headquarters located at 23748 W. 135<sup>th</sup> Street, Plainfield, IL.

Upon roll call the following Board members were present: Trustee John Eichelberger, Trustee David Riddle, Trustee Michael Obman; and Secretary Brian Stevens. President Bill Barnes arrived at 10:05 a.m.

Also present were Finance/HR Director Cheree Lewis, Administrative Assistant Mary Jo Fazio, A.J. Weber, Lauterbach & Amen, LLC, and Tom Sawyer and John Falduto, Sawyer Falduto Asset Management.

**Public Comment** – Nothing from the audience.

Minutes - A motion was made by Trustee Riddle to accept the meeting minutes from April 14, 2015, as prepared, seconded by Trustee Eichelberger. Upon a voice vote, the motion carried.

**Treasurers/Investment Report** – A.J. Weber from Lauterbach & Amen stated he does not have the current financial statements in order to give a Treasurers report at this time. He will review the bank transactions with Cheree Lewis after the meeting and will have a report for the next meeting.

Payment of Bills — Three bills from the District were presented to the Board that reflect Cheree Lewis and Mary Jo Fazio's time doing business for the Pension Board. The bills are from 2013, 2014 and 2015 to date. The total is \$38,793.53. After reviewing the invoices, a motion was made by Trustee Eichelberger to pay the invoices as presented, seconded by Trustee Obman.
