PENSION BOARD MINUTES OF JANUARY 12, 2016

Trustee Brian Stevens called the January 12, 2016 meeting of the Board of Trustees of the Plainfield Firefighters' Pension Fund to order at 4:00 p.m. with the Pledge of Allegiance at the District Headquarters located at 23748 W. 135th Street, Plainfield, IL.

A motion was made by Trustee Riddle to appoint Trustee Stevens as acting President for this meeting due to the absence of President Barnes, seconded by Trustee Obman. Upon a voice vote, the motion passed.
