Those in attendance were Commissioner Dale Hurley & Commissioner William Anderson. Commissioner Arnold Hartley was absent. Also present was Deputy Chief Vito Bonomo III and Administrative Assistant Nicole Irwin.

A motion was made to confirm the hiring of Kevin Teper to the position of Firefighter/Paramedic effective February 28, 2019, by Commissioner Dale Hurley, seconded by Commissioner William Anderson; motion approved by a 2-0 voice vote.** The Commissioners congratulated Deputy Chief Vito Bonomo III and wished him well in his new rank.
