BOARD OF FIRE COMMISSIONERS

Commissioner Dale Hurley called the meeting of the Board of Fire Commissioners of the Plainfield Fire Protection District to order on Wednesday, February 27, 2019 at 3:02 p.m. at the PFPD Headquarters, 23748 W. 135th St., Plainfield, IL, with the Pledge of Allegiance. Those in attendance were Commissioner Dale Hurley & Commissioner William Anderson. Commissioner Arnold Hartley was absent. Also present was Deputy Chief Vito Bonomo III and Administrative Assistant Nicole Irwin.

No correspondence, bills or matters from the public.

A motion was made to accept the February 7, 2019 meeting minutes by Commissioner William Anderson, seconded by Commissioner Dale Hurley; motion approved by a 2-0 voice vote.

Old Business: Discussed the time line and 90 day notice for the Battalion Chief testing process. A motion was made to confirm the promotion of Brandon Vainowski to the rank of Lieutenant effective February 28, 2019, by Commissioner Dale Hurley, seconded by Commissioner William Anderson; motion approved by a 2-0 voice vote. A motion was made to confirm the hiring of Kevin Teper to the position of Firefighter/Paramedic effective February 28, 2019, by Commissioner Dale Hurley, seconded by Commissioner William Anderson; motion approved by a 2-0 voice vote. The Commissioners congratulated Deputy Chief Vito Bonomo III and wished him well in his new rank.
