## **BOARD OF FIRE COMMISSIONERS**

Commissioner Dale Hurley called the meeting of the Board of Fire Commissioners of the Plainfield Fire Protection District to order on Wednesday, May 22, 2019 at 3:00 p.m. at the PFPD Headquarters, 23748 W. 135<sup>th</sup> St., Plainfield, IL, with the Pledge of Allegiance. Those in attendance were Commissioner Dale Hurley, Commissioner Arnold Hartley & Commissioner William Anderson. Also present was Chief Jon Stratton, Deputy Chief Vito Bonomo III and Administrative Assistant Nicole Irwin.

No correspondence or matters from the public.

A motion was made to accept the April 24, 2019 meeting minutes by Commissioner Arnold Hartley, seconded by Commissioner Dale Hurley; motion approved by a 3-0 voice vote.

A motion was made to pay the bill to Illinois Police and Fire Commissioners' for Arnold Hartley to attend the seminar by Commissioner Dale Hurley, seconded by Commissioner William Anderson; motion approved by a 2-0 voice vote. Commissioner Arnold Hartley abstained from voting.

Old Business: The letters of intent for the BC testing were reviewed. Deputy Chief Vito Bonomo was in touch with Steve Hale from the testing company and they have set up the following tentative dates for the testing process: Interviews will be on Wednesday, September 18, Assessment Center Orientation will be Thursday, October 3, Assessment Center will be Wednesday, October 9 and the written exam will be on Friday, November 8. All dates are on black shift to accommodate the personnel testing. The notice for testing was signed and will be sent via email to the union and the personnel who are testing. Commissioners and Chiefs reviewed the interview questions and discussed who they would like to have assist with the interviews. Chief Stratton and Deputy Chief Bonomo will get some questions together and ask other chiefs about helping out for the interviews.

New Business: A motion was made by Commissioner Dale Hurley to approve the appointment of Jackson Treasure as a Firefighter/Paramedic effective May 9, 2019, seconded by Commissioner Arnold Hartley; motion approved by a 3-0 voice vote.

The next meeting will be Wednesday, July 31, 2019 at 3:00 p.m. at HQ, with discussion of a special meeting if needed. There being no further business, a motion was made by Commissioner Dale Hurley to adjourn the meeting at 3:23 p.m., seconded by Commissioner Arnold Hartley; all in favor.
