## **BOARD OF FIRE COMMISSIONERS**

Commissioner Dale Hurley called the meeting of the Board of Fire Commissioners of the Plainfield Fire Protection District to order on Monday, November 11, 2019 at 3:00 p.m. at the PFPD Headquarters, 23748 W. 135<sup>th</sup> St., Plainfield, IL, with the Pledge of Allegiance. Those in attendance were Commissioner Dale Hurley, Commissioner Arnold Hartley & Commissioner William Anderson. Also present were Chief Jon Stratton and Administrative Assistant Nicole Irwin.

A motion was made to accept the October 2, 2019 meeting minutes by Commissioner Arnold Hartley, seconded by Commissioner William Anderson; motion approved by a 3-0 voice vote.

A roll call vote was taken to pay the bills for the Illinois Police & Fire Commission Association - membership dues: \$375, RMA – Assessment Center BC promotional testing; \$5,728.38, Stanard & Associates – personality evaluations; \$2,765 and Ottosen, Britz, Cooper, Gilbert & Dinolfo – attorney fees; \$382.50 for a total of \$9,250.88. Roll call vote was taken as follows: Commissioner Arnold Hartley – Yes; Commissioner William Anderson – Yes; and Commissioner Dale Hurley – Yes.

The next meeting will be held on Monday, November 25, 2019 at 3:00 p.m. at HQ. There being no further business, a motion was made by Commissioner Dale Hurley to adjourn the meeting at 3:31 p.m., seconded by Commissioner Arnold Hartley; all in favor.
