## BOARD OF FIRE TRUSTEES SPECIAL MEETING

Trustee Barnes called the special meeting of the Board of Trustees of the Plainfield Fire Protection District to order at 9:00 a.m. held on Friday, December 27, 2019, at the Fire District Headquarters, 23748 W. 135<sup>th</sup> St., Plainfield, IL with the Pledge of Allegiance.

A roll call attendance was taken as follows: Trustee Bob Baish – present; Trustee William Barnes - present; Trustee Doug Shreve – present. Trustee Tom Paul arrived at 9:02 a.m. Trustee Ted Peszynski was absent.

Also in attendance were Chief Jon Stratton; Deputy Chief Vito Bonomo and Administrative Assistant Mary Jo Fazio. Executive Board members from Local Union 4560 were also in attendance.

Open Forum – Nothing at this time.

Business – A motion to approve the 4560 Collective Bargaining Agreement (CBA). A motion was made by Trustee Baish to accept the CBA as voted on by Local Union 4560.
