Bills to be paid- Comcast \$1,500.00 Knife sharpening \$732.00

Broadus made a motion to approve the bills. Seconded by Eichelberger all in favor none opposed.

## **Old Business-**

**Live Scope-** ordered, received and paid for. Ordered the mount and should arrive within the month.

**Building construction prop-** In line to receive our prop. The prop will be built and total cost for build and shipping will be sent.

## New Business-

New Station grills- 3 burner Webber grills. Grills will be ordered from Ace hardware in town.

Gas shut off timer- Shut off timers for each new grill.

Broadus made a motion to approve the purchase of 5 new grills. Not to exceed \$6,000 for everything. Seconded by Deliberto all in favor none opposed.

Office chairs for 3 and 4- new chairs for both the stations at \$101.70 each. Total of 7 chairs.

Broadus made a motion to approve the purchase of new office chairs not to exceed \$800.00. Seconded by Eichelberger. All in favor none opposed.

**Row machine for Station 3-** Adding a row machine to station three as well as adding a row machine to station 4 as well. Health and safety will pick the model and will not exceed the cost of \$1,000.00 each.

Deliberto made a motion to purchase 2 row machines not to exceed \$2,000.00 for station 3, and station 4. Seconded by Broadus. All in favor none opposed.

Deliberto made an amended motion to not exceed \$2,500.00 for both rowing machines with shipping cost. Seconded by Broadus. All in favor none opposed.

**Spring Health and Fitness item**- Shoes to be bought annually. \$100.00 per person for a pair of shoes from DNA. Cost over \$100.00 will be covered by member.

Broadus made a motion to start spring health and safety item for shoes annually as a 50/50 split with the district. Cost not to exceed \$100.00 per member. Seconded by Deliberto. All in favor none opposed.
