Semi-Annual Review of Closed Session Meeting Minutes: There were no closed session meeting minutes for review.

ACCOUNTANT'S REPORT – LAUTERBACH & AMEN, LLP: Monthly Financial Report: The Board reviewed the Monthly Financial Report for the eleven-month period ending November 30, 2021 prepared by L&A. As of November 30, 2021, the net position held in trust for pension benefits is \$41,022,236.73 for a change in position of \$5,190,298.18. The Board also reviewed the Cash Analysis Report, Revenue Report, Expense Report, Member Contribution Report, Payroll Journal and vendor check report for the period of September 1, 2021 through November 30, 2021 for total disbursements of \$60,235.08. Review/Update Cash Management Policy: This item was not discussed.

Investment Performance Report: Mr. Sawyer presented the Quarterly Investment Performance Report for the period ending December 31, 2021. As of December 31, 2021, the fourth quarter net return is 3.6% versus the benchmark of 4.5%. The investment return for the quarter is \$1,450,355 for an ending market value of \$41,833,570. The current asset allocation is as follows: fixed income at 43.5%, equities at 56.0% and cash equivalents at 0.5%. Mr. Sawyer reviewed the Market Commentary, Equity and Fixed Income Portfolios, Credit Rating Report and Transaction Ledger Report with the Board. A motion was made by Trustee Lough and seconded by Trustee Barnes to accept the Quarterly Investment Performance Report as presented. Motion carried by roll call vote.

The Board also noted that the appointed member position held by Trustee Barnes is expiring in April 2022 and he is interested in remaining on the Board. The Board will contact the District and seek reappointment of Trustee Barnes to the Board.

Discussion/Possible Action – Review of Non-IFPIF Account Holdings: The Board discussed the Non-IFPIF account holdings and noted that all non-money market assets were swept.

ATTORNEY'S REPORT – OTTOSEN: Legal Updates: Attorney Motylinski provided legislative updates pertaining to Article 4 Pension Funds; including recent court cases and decisions, as well as general pension matters.

Disability Benefits Status Update – Adam Slick and Joel Moore: The Board noted that the non-duty disability calculation for Joel Moore is in process and further discussion will be held at the next regular meeting.

Attorney Motylinski informed the Board that Adam Slick has his first independent medical evaluation is scheduled for January 11, 2022. Further discussion will be held at the next regular meeting.

QILDRO – Joseph Schroeder: The Board noted that QILDRO documentation has been received for Joseph Schroeder and placed on file for execution upon his retirement.
